**Definitions.**

- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

## Progress Report

### **Expanding supply of affordable units**

The Department implemented payment standards between 90% and 110% in areas where market rents were high and there is high demand for rental units it can be challenging for a voucher holder to find a unit. Increased FMRs will aid in areas where voucher holders have had difficulty in finding acceptable units or affording units in more desirable areas. Higher FMRs provide additional choices and opportunities to tenants in highly competitive rental markets. In areas where market rents are higher than 110%, poverty levels are lower, schools are better and there are more opportunities for employment. Ensuring that a household's voucher provides enough assistance to house them and the vouchers is not over-subsidized.

### **Utility Payment Schedules (HCV)**

The policy regarding utility payment schedules was modified to include HUD's mandated language under the administrative streamlining guidance. The established utility allowance schedule is used in determining family share and the Department's subsidy. The Department is using the appropriate utility allowance for the lesser of the size of dwelling unit actually leased by a family or the voucher size issued for which the family qualifies using the Department's subsidy standards.

In cases where the unit size leased exceeds the family's unit size as determined under subsidy standards as a result of a reasonable accommodation, the Department will use the utility allowance for the size of the dwelling unit actually leased by the family.

### **ASSETS [24 CFR 5609(b)(3), and 24 CFR 5603(b) and 24 CFR 960259]**

On March 8, 2016, HUD published the Streamlining Rule in the Federal Register. This rule made permanent changes to the way assets were verified, although with modifications to the process outlined in Notice PIH 2013-03. The approved method to reduce administrative burden and streamline income re-certification efforts states the (1) Applicants must provide full third party verification (i.e. bank statements) at the time of determination of income eligibility. (2) For a resident family with net assets equal to or less than \$5,000, a PHA may accept, for purposes of re-certification of income, a family's declaration that it has net assets equal to or less than \$5,000, without taking additional steps to verify the accuracy of the declaration. The declaration must state the amount of income the family expects to receive from such assets; this amount must be included in the family's income. However, the PHA must obtain full third-party verification of assets every three years.

### **VAWA**

The mission of TDHCA's Section 8 Housing Choice Voucher Program is to provide financial rental assistance on behalf of low income individuals and families, including the elderly and persons with disabilities for decent, safe, sanitary and affordable housing.

The Department implemented HUD revised guidance regarding Violence Against Women and Department of Justice Re-authorization Act 2013 (VAWA) comply with the Violence Against Women Act to support and assist victims of domestic violence, dating violence, sexual assault, or stalking.

The Administrative Plan has been updated to reflect the Department's Eligibility policy prohibiting denial of assistance to victims of domestic violence, dating violence, and stalking as required by VAWA. In addition to the transfer and termination of assistance policies reflective in the VAWA objectives and requirements. The Department implemented HUD published guidance regarding major provisions of the Housing Opportunity Through Modernization Act (HOTMA). Provisions of this notice was effective April 18, 2017.

### **Housing Opportunity through Modernization Act (HOTMA)**

On July 29, President Obama signed into law **Housing Opportunity through Modernization Act (HOTMA)** Inspection of Dwelling Units for *Initial Inspections*

Housing Need.

Based on information provided by the applicable Consolidated Plan, information provided by HUD, and other generally available data, make a reasonable effort to identify the housing needs of the low-income, very low-income, and extremely low-income families who reside in the jurisdiction served by the PHA, including elderly families, families with disabilities, and households of various races and ethnic groups, and other families who are on the public housing and Section 8 tenant-based assistance waiting lists. Housing Need Analysis- Section 8

When analyzing local housing markets and developing strategies for meeting housing challenges, HUD suggests the consideration of several factors. These factors include how much a household spends on housing costs, the physical condition of housing and whether or not the household is overcrowded.

An excess cost burden is identified when a household pays more than 30 percent of its gross income for housing costs. When so much is spent on housing, other basic household needs may suffer.

The measure of physical inadequacy is the number of units lacking complete kitchen and/ or plumbing facilities. While this is not a complete measures of physical inadequacy, the lack of plumbing and/ or kitchen facilities can serve as a strong indication of one type of housing inadequacy.

Overcrowded housing conditions may occur when a residence accommodates more than one person per each room in the dwelling. Overcrowding may indicate a general lack of affordable housing in a community where households have been forced to share space, either because other housing units are not available or because the units are too expensive.

The following table estimates the number of low-income households with housing needs for the 37 TDHCA Section 8 service areas. The figures are adjusted to 2015 levels based on population growth estimates.

The TDHCA waiting list is approximately 700 applications. The waiting list figure is a composite of several statewide jurisdictional waiting lists, as well as the Project Access waiting list. There is no waiting list for the Project-Based VASH program.
