

INFORMATION APPLICABLE TO PROCLAMATIONS TO BE USED IN SCORING DISASTER POINTS

LIMITATIONS ON THE TYPE OF DISASTER DECLARATION

10 TAC §11.9(c)(8) (related to Criteria to serve and support Texans most in need - Readiness to proceed in disaster impacted counties)

Due to uncertainty linked to the COVID-19 pandemic, scoring for all Applicants under this item is suspended (no points may be requested, nor will they be awarded) for 2021 HTC Applications. Applications in the At-Risk or USDA Set-asides are not eligible for these points.

10 TAC §11.9(d)(3) (related to Criteria promoting community support and engagement - Declared **Disaster Area**)

To qualify for points under this scoring item, an Application for a proposed Development must be located in a county declared a disaster by the Governor under Tex. Gov't Code §418.014 related to **Declaration of State of Disaster** within the two years preceding the date of Application submission. Any other declarations, including presidential and FEMA declarations for areas that do not meet this requirement, will not qualify for points under this scoring item. Page three of this document includes a list of the counties that are eligible for ten points under 10 TAC §11.9(d)(3) of the QAP.

APPLICABLE TIME LIMITS

For Applicants wishing to score points for a Development to be located in one of these counties, a complete Application must be received prior to 5:00 p.m., Austin local time on March 1, 2021.

If additional counties are declared prior to March 1, 2021, the lists will be updated.
