

NOTICE OF PUBLIC HEARING

TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS MULTIFAMILY HOUSING REVENUE BONDS (HONDO BRIAN PLACE AND HONDO GARDENS DEVELOPMENTS)

Notice is hereby given of a public hearing to be held by the Texas Department of Housing and Community Affairs (the "Issuer") at the Hondo Public Library, 2003 Avenue K, Hondo, Texas 78861 at 12:00 p.m. on April 17, 2018. The hearing is regarding two issues of tax-exempt multifamily residential rental development revenue bonds in an aggregate principal amount not to exceed \$4,400,000 and taxable bonds, if necessary, in an amount to be determined, to be issued in one or more series by the Issuer (the "Bonds") to finance a portion of the costs of the two multifamily housing developments described below (the "Developments").

Proceeds of the Bonds in an aggregate amount not to exceed \$2,600,000 will be loaned to THF Hondo Brian Place, LLC, a Texas limited liability company, or a related person or affiliate thereof (the "Hondo Brian Place Borrower"), to finance a portion of the costs of acquiring and rehabilitating a multifamily housing development. The housing development is described as follows: an approximately 40-unit multifamily housing development located at 231 Stage Coach Drive, Hondo, Medina County, Texas 78861 (the "Hondo Brian Place Development"). Upon the issuance of the Bonds, the Hondo Brian Place Development will be owned by the Hondo Brian Place Borrower.

Proceeds of the Bonds in an aggregate amount not to exceed \$1,800,000 will be loaned to THF Hondo Gardens, LLC, a Texas limited liability company, or a related person or affiliate thereof (the "Hondo Gardens Borrower"), to finance a portion of the costs of acquiring and rehabilitating a multifamily housing development. The housing development is described as follows: an approximately 32-unit multifamily housing development located at 3100 Avenue Q, Hondo, Medina, County, Texas 78861 (the "Hondo Gardens Development"). Upon the issuance of the Bonds, the Hondo Gardens Development will be owned by the Hondo Gardens Borrower.

All interested parties are invited to attend such public hearing to express their views with respect to the Developments and the issuance of the Bonds.
