

By-laws of South Timber Ridge Resident Council, Inc., a Texas Nonprofit Corporation

Article |

Purpose

The Corporation shall provide for the betterment and general welfare of the residents of Timber Ridge Apartments, preserve the character of the Timber Ridge Apartments, and engage in community projects for the benefit of the residents of Timber Ridge Apartments.

Article II

Service Area

The Service Area of the Corporation shall be the neighborhood consisting only of the Timber Ridge Apartments

Article III

Membership

- (1) Eligibility: All Current Residents of the Timber Ridge Apartments who are eighteen years of age or older shall be eligible for membership in the Corporation.
- (2) Rights of Members: Each member of the Corporation shall be entitled to one vote on each matter submitted by the President to a vote at a Regular or Special meeting. The President has the discretion to decide which, if any, matters shall be submitted to the membership for a vote, except those decisions which must be submitted to members for a vote as required by Texas law. No member shall be entitled to any dividend or part of any income of the Corporation or to any share in the distribution of the Corporate assets upon dissolution.

(3) Regular Membership Meetings: The Membership shall meet at least once each calendar year, at a time and date designated by the President, for the purpose of transacting any business that the President may submit to the members, and to elect, by majority vote of the members present at such meetings, a President and a Secretary who shall serve one year terms, or until their successors have been selected.

Article IV

Management and Operations

- (1) Management: The Corporation elects to be be managed by its Members.
- (2) Officers: Each calendar year, the Members shall elect a President and a Secretary, who shall be Members, and who shall serve one-year terms. The President and Secretary shall have the authority to act on behalf of the Corporation. The President and the Secretary shall remain in office until their successors have been selected, and may serve consecutive terms without limit.
- (3) Execution of Documents: The President shall be authorized to execute all contracts and any legal written instruments in the name of and on behalf of the Corporation.
- (4) Records: The Secretary of the Corporation will keep correct and complete records of account and minutes of the proceedings of all meetings, and make such records reasonably available to all members.
- (5) Fiscal Year: The fiscal year for the Corporation will be the calendar year, January 1 to December 31.


