#### I. Welcome and Introductions

Mike Doyle called the meeting to order at 10:05 am and all attendees introduced themselves. It was confirmed that a quorum was present.

#### II. Remarks from Chair

Mike Doyle reminded everyone that members were asked at the last meeting to provide a legislative update from their agencies at this meeting.

### III. Approval of draft minutes from the April 11, 2017 TICH Meeting

Mike Doyle introduced the draft minutes from the January 31, 2017, TICH meeting. Jennifer Molinari, attending at proxy for Naomi Cantu, moved to approve and Pam Maercklein seconded. There were no comments and members voted aye unanimously to approve the minutes.

# IV. Appoint Board Chair and Vice-Chair (Voting Item)

Cate Tracz reported that one nomination was received for Mike Doyle to continue as Chair of the TICH. Mike Doyle accepted this nomination. There were no comments and members voted aye unanimously to approve Mike Doyle as the Chair. Mike Doyle indicated that he would be appointing a Vice-Chair later in the year in accordance with TIHC bylaws.

#### V. 85th Session Legislative Updates

Legislative updates were provided from Michael Lyttle of TDHCA, Francis Gattis of TDCJ, Valinda Bolton of DFPS, Kelly Kravitz of TEA, Pam Maercklein of TVC, Todd Novak of TJJD, and DJ Bingler of TWC. In conjunction with the TWC update, Mike Doyle referenced the next agenda item and thanked DJ Bingler and the TWC for the funds provided to the TICH. In the absence of an HHSC representative, Eric Samuels offered updates on HHSC's Health and Community Collaborative.

# VI. Use of \$10,000 provided by Texas Workforce Commission for Continuum of Care Coordination by Texas Homeless Network (Voting Item)

Eric Samuels provided an overview of how THN has used FY 2017 TWC provided funds for coordination with local Workforce Development Boards. Building on the success of this coordination, it was discussed and Jennifer Molinari made a motion to use the FY 2018 TWC provided funds to extend these coordination efforts to the Continuum of Care leads. Pam Maercklein seconded. There were no comments and members voted aye unanimously to approve the motion.

#### **VII. Discuss TICH Committees**

Eric Samuels provided an update of the activities of the Annual Report Committee and Cate Tracz provided an update of the Performance Data Committee on behalf of Brooke Boston.

#### **VIII. Public Comment**

Eric Samuels provided an Infographic handout showing a 31% decline in homelessness among Texans over the past 6 years, based on PIT count data from 2012 through 2017. A discussion ensued about the definition of homelessness and the rate of population growth.

## **IX. Closing comments**

Mike Doyle reminded attendees that the next quarterly TICH meeting will be held on October 4, 2017, in Dallas, in conjunction with the THN Annual Conference on Ending Homelessness.
