I. Welcome and Introductions

Mike Doyle called the meeting to order at 10:07 am and all attendees introduced themselves. It was confirmed that a quorum was present.

II. Remarks from Chair

As there were many guests present from THN's Annual Conference on Ending Homelessness, Mike Doyle welcomed everyone and provided an overview of the TICH, including the legislative mandated activities, annual report and successful collaboration efforts with the THN.

III. Approval of draft minutes from the July 11, 2017 TICH Meeting

Mike Doyle introduced the draft minutes from the July 11, 2017, TICH meeting. Kelly Kravitz moved to approve and Todd Novak seconded. There were no comments and members voted aye unanimously to approve the minutes.

IV. Conversation with the United States Interagency Council for the Homeless (USICH)

Matthew Dougherty and Bob Pulster of USICH were both present to address the attendees. Updates were provided on disaster recovery efforts, federal budget impacts on USICH operations, revisions to the *Opening Doors* document, and coordination with federal, regional, and state partners. A discussion ensued about the criminal justice system and recidivism.

V. Conversation with Continuum of Care agencies

Each of the CoC leads present addressed the group and reported on recent activities including disaster relief efforts, employment barriers, and mental health. Discussion continued with members from state agencies on these topics.

VI. Report from TDHCA Homelessness Staff on Status of ESG

Michael Lyttle provided an update on the Texas Ending Homelessness Fund. Beginning January 1, 2018, Texans can donate to this fund when they register or renew registration for their vehicle. TDHCA is in the process of developing rules to administer the funds and attendees were informed on how to provide input and spread the word about this new funding source to address homelessness in Texas. Naomi Cantu then provided and update on ESG contracts and awards for the 2017-2018 program year.

VII. Update on VISTA Volunteer Project on §2306.905(7)

Megan Moore provided an update on the VISTA volunteer project and spoke about surveying CoC's about their coordination with workforce development boards.

VIII. Updates from TICH Committees

Brooke Boston provided an update on the Performance Data Committee. Information on performance data has been gathered from TDCJ and Brooke Boston plans to meet with TVC and TEA next. Discussion continued about the criminal justice system, recidivism, and related data. Eric Samuels then provided an update of the activities of the Annual Report Committee.

IX. Public comment

Dennis Scholl thanked TDHCA staff for their coordination of the meeting and THN staff for their work.

X. Closing comments

Mike Doyle thanked everyone for attending and commended the CoC's for their work and collaboration.
