What is CSBG?

The Community Services Block Grant is a *federal block grant* designed to provide assistance to state and local communities working through a network of community action agencies and other neighborhood-based organizations, for:

- ❖ the reduction of poverty,
- ❖ the revitalization of low-income communities, and
- ❖ the empowerment of individuals to become fully self-sufficient.

Chronology

1964:

Congress passed the Economic Opportunity Act (EOA) establishing funding for Community Action Agencies and Programs and providing the focus for CAAs

- ❖ EOA created the Community Action Network
- ❖ 1000 CAAs across the nation

1970:

Office of Economic Opportunity (OEO) established the mission and model of Community Action.

- ❖ Individuals increase opportunity and independence
- ❖ Community revitalization
- ❖ Mobilization of resources
- ❖ Working partnerships
- ❖ Agency accountability

Chronology (continued)

1973:

Economic Opportunity Commission replaced by Community Services Act, but the mission remained the same

1981:

Community Services Act replaced with the CSBG Act of 1981

- ❖ States became the pass-through entity for funds
- ❖ Changed the relationship between the local CAAs and the Federal Government
- ❖ Mission stayed the same

Chronology (continued)

1993:

- ❖ Congress passed the Government Performance and Results Act (GPRA)
 - ❖ This renewed emphasis on accountability.
 - ❖ Established performance goals and indicators

1994:

Amendment to the CSBG Act passed in response to the GPRA

- ❖ Required outcome measures in three areas
 - ❖ Promoting Self Sufficiency
 - ❖ Family Stability
 - ❖ Community Revitalization

Chronology (continued)


1998:


- ❖ Passed the 1998 Reauthorization of the CSBG Act
 - ❖ Mandated implementation of a comprehensive performance-based management system = ROMA
 - ❖ This is the current reauthorization that we presently operate under

2001:


- ❖ Information Memorandum 49
 - ❖ Goal 1: Low-income people become more self-sufficient.
 - ❖ Goal 2: The conditions in which low-income people live are improved.
 - ❖ Goal 3: Low-income people own a stake in their community.
 - ❖ Goal 4: Partnerships among supporters and providers of service to low-income people are achieved.
 - ❖ Goal 5: Agencies increase their capacity to achieve results.
 - ❖ Goal 6: Low-income people, especially vulnerable populations, achieve their potential by strengthening family and other supportive systems.

Indicators provide a means to measure achievement of or movement towards the long term goals.




Document the number of people who received services and the number who achieved outcomes.



Provide data for analysis:

- What change was expected and what happened?
- How does the actual change compare with the expected change?
- How accurate were the projections?
- What percent of people served achieved the outcome?

Individuals and families at or below 125% of the federal poverty income guidelines.

Eligibility for CSBG is calculated at 125% of Federal Poverty Income Guidelines.

Use of Federal Funds

- ❖ Per the CSBG Act, 90% of the federal CSBG funds allotted to the State are allocated to 40 CSBG eligible entities covering all 254 counties in Texas.
- ❖ 5% of the federal funds allotted to the state are reserved to provide services for:
 - ❖ emergency needs that arise as a result of man-made or natural disasters including, hurricanes, tornadoes and floods;
 - ❖ eligible applicants submitting proposals to conduct innovative projects in support of activities described in the CSBG Act; and
- ❖ 5% of the federal funds may be used to provide administrative support for the State office.

CSBG Allocation Formula

For 2018, the Department will distribute CSBG funds to CSBG eligible entities based on the distribution formula which incorporates:

- ❖ the 2010 Census figures at 125% of poverty;
- ❖ a \$50,000 base;
- ❖ a 150,000 floor;
- ❖ 98% weighted factor for poverty population; and
- ❖ 2% weighted factor for the inverse ratio of population density.

- ❖ Based upon a Community Needs Assessment
- ❖ Align with CAA's mission
- ❖ Activities may be done directly or through partnerships
- ❖ Provide referral information to other providers
- ❖ Fall within the allowable service categories

Case Management Defined

What is Case Management?

Case Management is:

- ❖ the process of identifying needs, providing services and/or referring clients to social, legal, health and emergency services;
- ❖ working with clients to develop solutions to problems and coordinating and monitoring progress made toward resolution of problem(s);
- ❖ representing clients or advocating on behalf of clients with other service providers to assure that needed services are provided.

Transitioning Persons Out of Poverty

- ❖ Transitioning out of poverty occurs after clients have gone through the process of case management, met their goals, and a change in income has occurred to bring the household income to 125% (or more) of the poverty guidelines.

Reporting Clients Transitioned Out of Poverty

- ❖ When can I report a client as transitioned out of poverty?
After they have been tracked for 90 days and have 90 days of income receipts to show that they remained above the poverty level for the entire period.

Managing the Case Load

- Case Managers case manage most clients to some degree but not all clients will have the desire to transition out of poverty.
- Case Managers must select the most ideal clients for transitioning out of poverty. Clients must have the desire and drive to take the necessary steps to change their economic situation.

Other programs and Case Management

Many different programs utilize the term case management to refer to:

- ❖ providing services, i.e. health services, mental health services, direct services etc...
- ❖ attainment of results such as energy self sufficiency or family self sufficiency.

In CSBG tasks/goals are centered around activities and services that assist clients to move their income levels from below poverty to above poverty.

Case Management Process

SERVICE COORDINATION

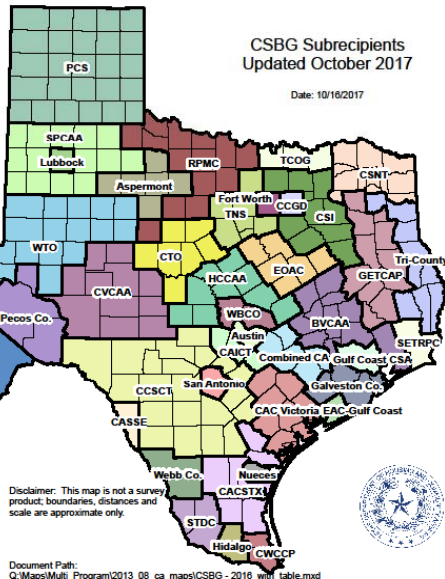
- Referrals should be provided as appropriate to the client's needs.
- Linkages should be established and maintained between programs and providers.
- Detailed directories of services in the community should be maintained.
- Confidentiality of clients' records should be maintained in accordance with program standards/agreements.

3	What is a private non-profit organization?	Community Action Agencies may be several types of organizations, not just private nonprofit organizations. For more information about nonprofit organizations, please see the Texas Secretary of State's website at https://www.sos.state.tx.us/corp/nonprofit_org.shtml . Please note that Emergency Solutions Grants eligible Subrecipients that are Private Nonprofit Organizations need to meet the definition in 10 Texas Administrative Code §7.2004(a): "those Private Nonprofit Organization(s) that are secular or religious organizations as described in §501(c) of the Internal Revenue Code of 1986, are exempt from taxation under Subtitle A of the Code, have an accounting system and a voluntary board, and practice non-discrimination in the provision of assistance."
