The hearing is regarding the issuance of obligations by the Issuer, which may be issued pursuant to a plan of finance in one or more series, in an aggregate principal amount not to exceed \$50,000,000 (the "Bonds"). The Bonds will be issued as exempt facility bonds for a qualified residential rental project pursuant to section 142(a)(7) of the Internal Revenue Code of 1986, as amended (the "Code"). Proceeds of the Bonds will be loaned to LDG The Crossing at Clear Creek, LP, or an affiliate thereof (collectively, the "Borrower") to partially finance an affordable multifamily housing development (the "Development") that will be located at or near the northeast corner of Highway 175 and Woody Road, Dallas, Dallas County, Texas 75253. The Borrower will be the initial owner and principal user of the Development.
